# CHAPTER-1. Introduction

User Manual of Landuse Purchase/Change Permission under Z-A and LR Act is an internal document of NIC. No part of this document shall be reproduced without the prior permission of Board of Revenue, NIC Dehradun Uttarakhand.

#### 1. Document:

The Landuse Management System User Manual has details of Landuse Purchase/Change permission Acts Under Z-A & LR. Landuse Management software developed for the Computerization of Landuse Purchase/change Permission under Z-A & LR Acts in Uttarakhand.

### 1.1 Intended Audience

Landuse Management System s/w will be implemented at all the Districts of Uttarakhand. Landuse Management System User manual will be used by the following.

- Land Revenue System Administrator BOR, DM, SDM, Tehsildar and Naib Tehsildar, who are the District level authorities for land record.
- Land Revenue Supervisors Registrar Kanoongos, Lekhpal, who are subordinate officers at tehsil level and are responsible for the land Permission.
- Users Applicant who apply for Land Permission under 143, 144 and 154 Acts.
- NIC Administrators who are responsible for the implementation of Land Permission Acts.
- **On site trainers** Trainers deputed by the Board of Revenue, Uttarakhand, who are responsible for the onsite training to all.

#### Scope

This document will cover all the tehsils, districts of Uttarakhand. This will guide the users at tehsils and districts for the smooth functioning of the software. It will help the NIC officers to implement the software in their district. This will help the revenue officials to manage and operate the land permission Acts software in their tehsils and districts. This is the only document to guide the staff at remote places like tehsils and districts.

### Purpose

The purpose of this document is to describe the operations and functioning of the Land Permission Acts web application. This will describe all the operations related to Landuse Purchase/change Permission under Z-A and LR Acts.

- Landuse Management System web application has been developed using JAVA Server Faces (MVC architecture) Framework as front-end and PostgreSql as the backend. It is published on Apache Tomcat Server. The operating environment details are given as below-

#### Software Architecture - Brief Overview of Model View Controller

- <u>Model View Controller or MVC as it is popularly called</u>, is a software design pattern for developing web applications. A Model View Controller pattern is made up of the following three parts:
- **Model** The lowest level of the pattern which is responsible for maintaining data.
- View This is responsible for displaying all or a portion of the data to the user.
- **Controller** Software Code that controls the interactions between the Model and View.
- MVC is popular as it isolates the application logic from the user interface layer and supports separation of concerns. Here the Controller receives all requests for the application and then works with the Model to prepare any data needed by the View. The View then uses the data prepared by the Controller to generate a final presentable response. The MVC abstraction can be graphically represented as follows.

#### The model

The model is responsible for managing the data of the application. It responds to the request from the view and it also responds to instructions from the controller to update itself.


#### The view

A presentation of data in a particular format, triggered by a controller's decision to present the data. They are script based templating systems like JSP, ASP, PHP and very easy to integrate with AJAX technology.

#### The controller


The controller is responsible for responding to user input and performs interactions on the data model objects. The controller receives the input; it validates the input and then performs the business operation that modifies the state of the data model.

As soon as we open the Land Permission Acts Web Application, We see the following screen.




After the creation of the new state, the organization of Chief Revenue Commissioner was established in the revenue department. On May 11th , 2012, to make this organization more efficient and dynamic, Board Of Revenue was created in place of the organization of Chief Revenue Commissioner. The Chairman, Board Of Revenue works as the H.O.D. for the personnel's of revenue department e.g. Revenue Sub Inspector / Lekhapal, Revenue Inspector, Ragistrar Kanoongo, Ministerial staff, Collection staff, Administrative officers/Senior Administrative officers from Tehsils and districts, Naib tehsildar and Tehsildar. The Board Of Revenue is the highest judicial body of the revenue department. It's headquarter is situated in Dehradun, the state capital. There are two circuit courts under the Board. One is held in Pauri and another in Nainital. Hearing of the cases from hill districts of Garhwal division, is conducted in circuit court Pauri while the cases from Kumaun division, are disposed of in the circuit court Nainital. Revenue cases from districts Dehradun and Haridwar are deati with at the headquarter.
